WATER AND NORMAL USAGE OF ELECTRICITY ARE FREE OF CHARGE

(ELECTRICITY AVAILABLE: 110 & 220 volts, 60 cycle)

**CONTRACTORS & LABOURERS**

No work may be performed by persons other than PYS employees or contractors who are registered to work within the premises of PYS. (All PYS Registered Contractors must be in possession of a valid/up to date Contractor Pass to be authorized to work at our facility). The only exception to this rule is maintenance of a minor or routine character, which is performed by the owner, his captain of record or registered crew. Soliciting for work by non-Peake Yacht Services employees or non-registered contractors is not allowed in this yard.

**ALL ANTIFOULING MUST BE APPLIED BY PEAKE YACHT SERVICES ANTIFOULING DEPARTMENT**, unless done by the Owner / Captain or registered Crew.

**WELDING**

Please note that, for SAFETY reasons, no welding may be carried out by anyone (including boat owners) other than by Peake Yacht Services **approved welding contractors**.

For a list of approved welding contractors, please apply to the FRONT Office between the hours of 8:00am and 4:00pm, Monday to Friday. A Gas Free Certificate is required before any welding/hot work activity commences

**LAUNCH BOOKINGS**

The Customer Service Office requires **five (5) working days** notice for bookings to launch. Boats will not be launched until all bills are settled in full. Boats may only stay in the travelift slip at the discretion of the travelift operator and there will be a charge made for this (see above).

**PAYMENT**

Please be advised that personal cheques are not accepted. Payment may be made by MASTERCARD, VISA, CERTIFIED CHEQUE, BANK WIRE TRANSFER and, of course, CASH! (Please allow at least ten working days for wire transfers as payment will not be considered made until received into Peake Yacht Services account).
